ABOUT THE FACULTY

Course Director- Derek Cuff, M.D.

Dr. Cuff joined his partners at Suncoast Orthopaedic Institute in 2007 with a subspecialty interest in shoulder and elbow surgery. Dr. Cuff specializes in performing minimally invasive arthroscopic procedures as well as complex shoulder and elbow reconstruction.

In 2012 Dr. Cuff was invited to join the prestigious American Shoulder &Elbow Surgeons (ASES) society. This organization is comprised of leading national and international orthopaedic surgeons specializing in surgery of the shoulder and elbow. Admission into the ASES society is by nomination only and based on sustained academic and research contributions to the field of shoulder and elbow surgery. Dr. Cuff is one of a small group of surgeons in the state of Florida to be elected to this society and given this honor, and he is one of the only surgeons in Sarasota, Manatee, Charlotte, Lee or Collier counties to achieve Active Member status in this organization. Dr. Cuff has a strong interest in clinical and basic science research of the shoulder and elbow. He has published multiple articles in peer reviewed international journals on these topics. Dr. Cuff has received several research awards for his work in this field including the prestigious Charles Neer Award which was presented to him in 2011 by the American Shoulder and Elbow Surgeons for outstanding clinical research.

Dr. Cuff graduated Cum Laude from the University of Maryland School of Medicine. He completed his orthopaedic residency in Baltimore, MD at the University of Maryland Medical System, and a portion of his training was also at the Johns Hopkins Hospital. He went on to complete subspecialty fellowship training in shoulder and elbow surgery in Tampa, FL at The Florida Orthopaedic Institute prior to moving to the Sarasota area.

<u>David Chan, M.D.-</u> Dr. Chan is a fellowship trained, Board Certified Orthopaedic hand surgeon. Prior to attending medical school at the University of Florida, Dr. Chan practiced as a Senior Physical Therapist at the University of Miami / Jackson Memorial Medical Center for 5 years. It was there rehabilitating victims of head trauma and spinal cord injured quadriplegics that he learned the importance of hand

function for independence and quality of life. He went on to complete a hand surgery fellowship at the prestigious Philadelphia Hand Center / Thomas Jefferson University Hospital. Dr. Chan practices at the Suncoast Orthopaedic Institute

<u>David Klein, M.D.-</u> Dr. David Klein was born and raised in New York City before moving with his family to Jacksonville, Florida. Board certified by the American Board of Orthopaedic Surgery; he holds a Certificate of Added Qualifications in Surgery of the Hand. At Kennedy-White Orthopaedics, Dr. Klein's practice includes surgery of the hand, elbow, and shoulder, including joint replacement and treatment of rotator cuff disease. Christopher L.Dillingham, M.D.- Dr. Dillingham is a board certified orthopedic surgeon and fellowship trained in hand, shoulder, and arm surgery. He specializes in the treatment of problems with rotator cuff disorders, carpal tunnel syndrome and nerve injury, joint replacement, arthritis surgery, fracture repair, foot and ankle disorders and tendon repair. He is an expert and considered a leader in performing, the technically difficult, total reverse shoulder surgery. Using minimally invasive surgical techniques, he performs procedures including arthroscopic surgery of the shoulder, elbow and wrist, and endoscopic carpal tunnel surgery. Recognized as a leader in the field of orthopedics, Dr. Dillingham has earned an invitation to the American Orthopedic Association Leadership Forum (AOA).

Dr. Dillingham has medical appointments and admitting privileges at many local medical facilities, including Sarasota Memorial Hospital, Doctors Hospital, Lakewood Ranch Medical Center, IMG (Intercoastal Medical Group) Ambulatory Surgery Center, Advanced Surgery Center, Doctors SameDay Surgical Center, and Gulf Coast Surgery Center.

He is an Indiana native and attended Purdue University as an undergraduate, earning a Bachelor of Science Degree with Distinguished Honors. He completed medical school at Indiana University and was inducted into the institution's prestigious Alpha Omega Alpha Honor Society. Dr. Dillingham performed his orthopedic internship and residency at the Greenville Hospital System in South Carolina and a one-year fellowship in Hand, Shoulder, and Arm Surgery at the University of Florida/Shands Hospital in Gainesville, Florida. Dr. Dillingham received specialty training and state-of-the-art expertise in the treatment of shoulder arthritis, including both traditional and reverse shoulder replacement.

Chosen by his surgical colleagues, Dr. Dillingham was honored to accept the position of Vice Chief of Surgery at Doctors Hospital.

Stephen Otte, M.D.- Dr. Otte is a fellowship-trained orthopedic surgeon who specializes in shoulder and elbow.
